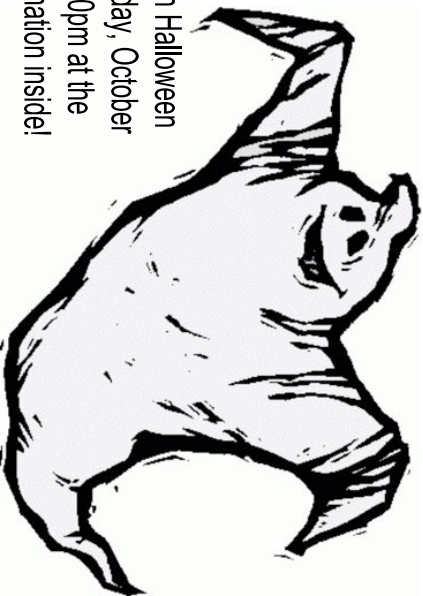
## LAKENGREN BOARD OF TRUSTEE CANDIDATES WANTED!
